Sl. No.	The school is directed to ensure that:
1	The total number of sections of the school shall be restricted to 21. Any further increase shall require prior approval of the Board subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	The clarification on the Land certificate and the details of Donor has been uploaded in the Mandatory Public Disclosure. The same may be uploaded on the SARAS portal.
3	The Library is poorly stocked. The school should procure more books in the Library as per CBSE norms i.e. 5 books per student and upgrade the library as per Sop issued by the board withion 3months and submit compliance on SARAS with videography. submit the compliance on SARAS portal within 3 months.
4	Existing cubicles have been converted as CwSN toilets which are therefore, very small and narrow and unnavigable by wheel chair users. The school should construct CwSN toilets separately for boys and girls as per specifications prescribed by the RPWD Act 2016 and submit the compliance through a videography on SARAS portal within 3 months.
5	The composite lab is not properly laid out. There should be work stations with built in utilities like water and piped gas supply for bio and chemistry section, the latter should also have shelves to keep the chemicals. The tables seen in the video can be used only for Physics section. The school shall upgrade the composite science lab as per SoP

	issued by the Board within 3months and submit compliance on SARAS with videography.
6	The school should upgrade the indoor sports facilities as per Sop issued by the Board and submit the compliance through a videography on SARAS portal within 3 months.
7	The school should ensure training of teachers with CoE Ajmer within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.

The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
